### **Coercion & Emotional Abuse**

A 1-day course

#### Aims:

- To increase healthcare staff's awareness, knowledge and understanding of safeguarding duties, regulations and responsibilities under the Care Act when working with adults at risk/victim of coercion and emotional abuse.
- To further develop the skills needed to tackle those issues confidently, by implementing safeguarding procedures where and when needed, and facilitating effective engagement, joint-working and information sharing.

#### Outcomes:

By the end of this 1-day course, you will have:

- Gained an increased and up-to-date knowledge and understanding of adult safeguarding roles and key regulations under the Care Act 2014, and how these apply or relate to coercion and emotional abuse
- Increased your knowledge and understanding of the Mental Capacity Act 2005 and its impact in the context of coercion and emotional abuse
- Improved your ability to raise your concerns and implement safeguarding procedures confidently, at any level, if you suspect someone is at risk
- Improved your ability to engage with a vulnerable adult who may be at risk of or is experiencing coercion and/or emotional abuse, by developing advanced communication skills to enhance disclosure and co-operation
- Familiarised yourselves with complex legal proceedings that require a jointworking strategy between healthcare and other statutory agencies, e.g. Inherent Jurisdiction of the High Court (situational incapacity, etc.)
- Gained an increased awareness of how to enhance prevention.

Note: In order to attend this course, all delegates must have attended the precursor ½ day session delivered in partnership with Hackney Workforce Development: Safeguarding Adults from Coercion & Emotional Abuse: General Awareness OR be able to demonstrate a higher level of understanding through current practice.
