Safeguarding Adults Awareness

A 1/2-day session

Aim:

- To ensure delegates understand that all individuals have the right to expect that their life experience will not include being abused.
- To explore why people become adults at risk of abuse and what human rights people have.
- To consider what role participants can have in preventing people being abused at work and as members of their local communities.

Outcomes:

By the end of the session the participants will:

- Understand dignity and respect when working with individuals and there importance in preventing abuse.
- To understand the approach underpinning Making Safeguarding Personal and how that impacts on expectations of participants practice.
- Be aware of the 6 principles of Safeguarding from The Care Act 2014 and other changes that are relevant to their role.
- Be aware of their own values and ethics and how these can impact on their involvement with adults at risk of abuse.
- Understand what Safeguarding is and what their roles are in the process.
- Be able to recognise an adult potentially in need of safeguarding and to respond appropriately and proportionally.
- Understand, and be confident with, the procedures for making and alert in Hackney

Impact assessment:

Safeguarding Adults Awareness: 6 months later.

- Staff can show a good understanding of the safeguarding process and their role within it including in the prevention of abuse.
- Staff can evidence an awareness of particular safeguarding risks in individuals for whom they are including the patterns of abuse and the new category of exploitation.
- Staff can confidently and proportionately 'make safe, report, and record' any concerns
